Dear Members of Oxford County Council,

I am writing to express my support for the speed management and road safety measures proposed for Oxford Road 40 (Curries Road) and to thank Transport Department and Public Works staff enormously for their initiative on this matter.

My family lives and farms on the hill east of Curries where our lane is hidden from the east by the brow of the hill.

Incidents of excessive speed and dangerous driving - by cars, trucks and even large transports - have become daily occurrences. The measures proposed by staff for Council's approval will be a great help toward calming the dangerous speeds on the road. Staff is also going to remove all passing lane markers from the top of the hill right to the Curries corner. We are so grateful for their response.

Greetings Frank,

I hope that all is well with you. I have been reviewing the proposed road safety measures for Oxford Road 40 east of Curries. As with many roads, we have had issues with speeding vehicles. This is a busy road for vehicles, pedestrians, cyclists, and farm equipment. In addition, we seem to attract an increasing amount of truck traffic. A few local businesses such as Fallowfield Excavating and Floral Express have added even more to this.

The presence of Start's Hill compounds the problems. Many vehicles speed up to take on the hill when heading east or they pick up speed coming down the hill when heading west. I have had vehicles attempt to pass me ascending the hill (unbelievable) as well as when descending. This is very dangerous given the short sightlines and the hidden driveways that exist. Curries Road is rather unforgiving as there is a lack of shoulders and no room to accommodate other drivers or pedestrians once speeders suddenly see them.

Warning signs and reducing the speed limit will help educate and alert drivers. Data gathering is also important and can be utilized by police for speed enforcement. Unfortunately, as we have seen at the intersection of Curries Road and Middletown Line, no amount of traffic calming can completely compensate for driver error and recklessness. Nonetheless I am very supportive of these proposed changes and hope that they will slow the traffic down along this section of road and make it safer for those of us living here.

Thanks for the response, Chloe, I really appreciate this.

I would like to also point to you the recent petition;

The population of Springford is around 400 according to the County of Oxfords website.

As of 6 hours there are already 85 signatures. Which is more than 20% of the population of our Village. I assume this will climb significantly by days end.

Delmer, Brownsville, Harley, Oxford Centre, Foldens, Sweaburg and Burgessville are all 50km Zones. All similar in size to Springford.

This is the email I sent to Mayor Jim Palmer, Could you please include this?

I think the consensus here in our community, is this is a bad idea.

Springford is Growing, the new houses on Main Street, the new cul-de-sac off water street, and many families moving to rural communities from larger ones.

There are approximately 35-40 children who get on the bus on Main street (19). These range from Woodstock Christian, Glendale High School, South Ridge Public, RCS in Norwich, and I am sure there is one more, as there are countless busses travelling through. There are approximately 8 bus stops in the proposed increased speed limit area with these kids.

Our Park is on the main street, for the kids to get to the park, they must walk on the north side of the road, where there is a sidewalk, and cross to the south to get to the park, over a proposed speed limit increased roadway.

There are also several walkers who use the main street sidewalk as exercise from one end of the village to the other. They range from Teenagers, to the elderly and retired.

The sidewalk is only on one side of the street, forcing walkers and bus riders to cross at least once. Either a) on the way to school, or b) on the way home.

We know the intersection with the zig zag on Main street and 13 has had multiple accidents, and many with farm equipment because of the speed that everyone travels through. Increasing the limit will only make this corner even worse for every commuter up and down county road 13. Everyone is in a hurry to get through and I have even witnessed cars taking a short cut through the gas station parking lot.

I have a camera set up in front of my house and the sensitivity was set rather high, so I received notifications every time a car drove by. I had over 600 vehicles between 4am and noon. The traffic is tremendous, and I know many people use Springford as a travel through to their destination, but we have to keep the residents in it safe, especially the kids!! **Thanks**

To Oxford County Council, meeting of June 14, 2023, this letter is my presentation.

I have been a resident, for over 50 years, on the affected portion of County road 40, Curries Rd, mentioned in the Speed Management and Road Safety report. My wife and I walk almost daily from our residence the entire designated zone to the 59 intersection. Other people walk this same section of road which has no side walks or provision for pedestrians or cyclists. This road is used by touring cyclists. Since it was paved many years ago it has become a popular road for transport trucks and other heavy vehicles. When the road was paved and resurfaced 3 or 4 times it adhered to a standard road width. As a pedestrian I observe that the road edges are repeatedly compromised by large vehicles particularly on the hill and certain driveway entrances to the detriment of the road bed. Also as a pedestrian the road margins are not easily to walk on so the road surface itself becomes the walking path.

That said, there are other significant issues as a motorist on county road 40, namely the intersection with highway 59. The volume of traffic has increased remarkably the past few years. It is not uncommon now to wait for 20 or 30 vehicles to pass before entering traffic. That is a change from years ago when that never happened. Anyone who wishes to cross from one side of 40 to the other side has to make a calculated dash across the 59 road because the intersection has a serious visibility issue to the north. Anyone crossing or making a left turn has to be very vigilant as oncoming traffic from the north rises over a nearby blind spot. In addition anyone turning left off of 59 coming from the north presents a rear end collision hazard while waiting to make their turn. However that intersection was not mentioned in the review.

Two of the proposals may impinge on my enjoyment of my property. These are an electronic speed sign and a hidden driveway sign. From the map these locations are not precise.

A hidden driveway sign existed adjacent to my property for several years but was relocated some meters to the east about 2020. That seemed a logical move because my drive and a neighbours drive both may be considered partially obscured. The proposal to add another hidden driveway sign essentially to replace the one relocated a few meters down the road seems redundant. The distance involved between the proposed and existing hidden driveway signs when travel time between them is considered at 70 kmh is between 5 and 10 seconds. The existing sign is purportedly useful for three driveways. The proposal is essential a sign per driveway. When the sign was moved two years ago several people who travel the road frequently were asked if they had noticed the sign had been moved. None said they even knew there was a sign or had been a sign. Thus the value of said sign or signs is likely pointless. I did notice that the sign, before it was moved, created a small obstruction of the view to west when I exited my driveway going west. When I make a left turn out of my driveway to go east there is a rise to the west that obscures oncoming traffic from the west, a definite hazard. When the road was reconstructed no effort was made to regrade that rise and I doubt that adding a sign on the south side of the road would alter the speed of any driver. Crossing the road to set out garbage requires an attentive ear to identify any oncoming traffic. I would not depend on a yellow road sign on the south side to save my life. I would suggest not adding another road sign on the north side as a suitable sign exists that covers the three driveways affected in a distance covered in a few seconds driving time.

As to the installation of an electronic feedback sign I hope that it's location would not be an annoyance to any property that might be adjacent, including mine. Perhaps integrating it with the existing hidden driveway sign may have some merit. As to turning this rural road into a quasi urban street changing the speed limit has some limited value. Some people slow down for pedestrians and many do not. Signs do not make safer roads, altering the nature of the road does.

In summary I wish to reiterate that the highway 59 egress and ingress to road 40 is a primary long standing hazard issue. That county road 40 ought to be wider, and the vertical curve (hill) be altered to improve line of sight. Adding a bicycle / pedestrian strip on the road would be an improvement. Adding more road sign clutter would not be an improvement as these signs can create visibility issues seeing oncoming traffic when entering the road.

Hello... My name is Brian Thomson. I am a resident of Verschoyle and South West Oxford.

I am writing concerning the proposed safety improvements regarding our community.

After reviewing the proposed changes, I would just like to add my comments for your consideration as I will not be able to attend the meeting as a delegate.

I feel that the proposed changes do not go far enough.... This road is very busy and a few plastic delinieators will not be adequate in the prevention of speeding traffic. In fact with the amount of commercial traffic and large farm tractors and equipment passing through the area, it would take no time at all for them to be run over and damaged by the above said vehicles. They would constantly need repair or replacement.

I am not sure why electronic speed feedback signs are not proposed for this area as they are for all others?

There is a large pedestrian presence on the days that Jtk Meat shop is open for business, as well, many of these people park on both sides of the road further reducing visibility to the speeding vehicles traveling through town. It is only a matter of time before someone is injured or killed under these circumstances....

I believe further safety measures are required in this area as they are at a very minimum compared to the proposals for the other areas. My suggestion would be a minimum of electronic feedback signs as well as further signage or establishing a community safety zone, flashing overhead amber lights, road painting of pedestrian crossing areas, speed bumps and a further reduction in the speed limits to a minimum of 50 kph.

Also it is possible to create and divert commercial truck traffic by creating a truck route to highway 19 which is more suited to handle these vehicles. These vehicles are some of the biggest speed offenders in this area as they short cut through many of your proposed communities on the way to Tillsonburg or Highway 3.

To summarize, I hope that you will further asses your study of traffic in this area and it issues as well taking my comments into consideration and make them available at the council meeting. Thank you for your time and consideration.
