

COUNTY OF OXFORD  
BY-LAW NO. 6554-2023

BEING a By-law to amend Schedule “A”, “B”, “C” of By-law 5725-2015, as amended, to provide for speed limits on County Roads.

WHEREAS, the Table to Section 11 and Section 52 (3) of the *Municipal Act, 2001, S.O. 2001, Chapter 25*, prescribes that specified highways are within the jurisdiction of the County of Oxford for all matters relating to those highways, including parking and traffic.

AND WHEREAS, the *Highway Traffic Act, R.S.O. 1990, Chapter H.8* authorizes a municipality to prescribe speed limits for motor vehicles driven on any highway or portion of a highway under its jurisdiction.

AND WHEREAS, Council passed By-law No. 5725-2015 containing Schedules “A”, “B”, “C” and “D” on August 12, 2015.

AND WHEREAS, Council passed amending By-laws No. 5764-2015, No. 5786-2016, No. 5817-2016, No. 5848-2016, No. 5859-2016 and its amending By-law No. 5881-2016, No. 5889-2016, No. 5934-2017, No. 6019-2018, No. 6086-2019, No. 6132-2019, No. 6177-2019, No. 6247-2020, No. 6280-2020, No. 6301-2021, No. 6339-2021, No. 6361-2021, No. 6373-2021, No. 6446-2022, No. 6510-2023 and No. 6529-2023.

AND WHEREAS, Council has adopted Public Works Report No. PW 2023-28, on June 14, 2023.

NOW THEREFORE, the Council of the County of Oxford enacts as follows:

1. That Schedule “B” of By-law No. 5725-2015, as amended by by-law 6529-2023, is hereby amended by removing the following wording:

“County Road 6 – North limit of County Road 12, Foldens to 570 metres North of the North limit of County Road 12, Foldens.”

2. That Schedule “B” of By-law No. 5725-2015, as amended by by-law 6529-2023, is hereby amended by revising the following wording:

“County Road 13 – 320 metres South of the South limit of County Road 19, Springford to 300 metres North of the North limit of County Road 19, Springford.”

3. That Schedule “B” of By-law No. 5725-2015, as amended by by-law 6529-2023, is hereby amended by revising the following wording:

“County Road 19 – 600 metres West of the West limit of County Road 13, Springford to 1030 metres East of the East limit of County Road 13, Springford.”

4. That Schedule “C” of By-law No. 5725-2015, as amended by by-law 6529-2023, is hereby amended by adding the following wording:

“County Road 6 – North limit of County Road 12, Foldens to 540 metres North of the North limit of County Road 12, Foldens.”

5. That Schedule “C” of By-law No. 5725-2015, as amended by by-law 6529-2023, is hereby amended by revising the following wording:

“County Road 10 – 465 metres South of the South limit of Ostrander Road, Culloden to 100 metres North of the North limit of Ostrander Road, Culloden.”

6. That Schedule “C” of By-law No. 5725-2015, as amended by by-law 6529-2023, is hereby amended by revising the following wording:

“County Road 10 – 1050 metres South of the South limit of Mount Elgin Road, Verschoyle to 135 metres North of the North limit of Mount Elgin Road between Con. 4 & 5, Verschoyle.”

7. That Schedule “C” of By-law No. 5725-2015, as amended by by-law 6529-2023, is hereby amended by revising the following wording:

“County Road 12 – 160 metres West of the West limit of County Road 6, Foldens to 195 metres East of the East limit of County Road 6, Foldens.”

8. That Schedule “C” of By-law No. 5725-2015, as amended by by-law 6529-2023, is hereby amended by revising the following wording:

“County Road 12 – 200 metres East of the East limit of Dodge Line, Sweaburg to West limit of Chele Mark Drive, Sweaburg.”

9. That Schedule “C” of By-law No. 5725-2015, as amended by by-law 6529-2023, is hereby amended by revising the following wording:

“County Road 27 – 325 metres West of the West limit of Dereham Line, Dereham Centre to 115 metres East of the East limit of Dereham Line, Dereham Centre.”

10. That Schedule “C” of By-law No. 5725-2015, as amended by by-law 6529-2023, is hereby amended by revising the following wording:

“County Road 40 – 300 metres East of County Road 59 to East limit of County Road 59, Curries.”

11. That Schedule “D” of By-law No. 5725-2015, as amended by by-law 6529-2023, is hereby amended by adding the following wording:

“County Road 12 – 150 metres West of the West limit of Trillium Line to the West limit of Chele Mark Drive, Sweaburg.”

12. That Schedule “D” of By-law No. 5725-2015, as amended by by-law 6529-2023, is hereby amended by adding the following wording:

“County Road 40 – 300 metres East of the East limit of County Road 59 to 2,000 metres East of the East limit of County Road 59, Curries.”

13. That Schedules “A”, “B”, “C” and “D” to By-law No. 5725-2015 with amendments consolidated to date are attached hereto and form part of this By-law.
