Amendments to the County of Oxford's Procedure By-law will be implemented and communicated immediately following adoption.


## **Financial Impact**

### DISCUSSION

# **Background**

In preparation for the Procedure By-law review, the Clerk requested input from each member of County Council with respect to any changes they would like considered through this process. A consultation meeting was also held with the Warden and Chief Administrative Officer for their input.

The Clerk conducted an informal poll with the Area Municipalities with respect to speaking limits for delegations and another poll with other County and Regional councils across Ontario with respect to evening meetings.

#### Comments

This report proposes amendments to the County's Procedure By-law, including customary housekeeping measures and some procedural matter improvements.

# Overview of Proposed Changes

Amendments to the County's Procedure By-law are tracked in Attachment 1 to this Report.

Proposed changes of significance and those which affect procedural matters are listed below:

- Section 3.2 (Inaugural Meeting), the time is changed to 4:00 p.m. (from 2:00 p.m.).
- Section 3.3 (Regular Meeting), subsection 3.3.1, regular meeting time is changed to 9:30
  a.m. for both the second and fourth Wednesday of each month (was 9:30 a.m. for
  second Wednesday and 7:00 p.m. for fourth Wednesday of the month) based on the
  results of a poll conducted of Counties and Regions in Ontario refer to Table 1 below.
- Section 6 (Order of Business), subsection 12 is updated to read "Enquiries" (was New Business / Enquiries / Comments).
- Section 9.1 (Notices of Motion), subsection 9.1.1, the deadline to providing a notice of
  motion is proposed to be shortened to six days preceding the date of the meeting at
  which such motion is to be introduced (was six full business days), allowing Councillors
  more time to submit a motion to the agenda for consideration at the meeting.
- Section 11.2 (Delegations, Presentations and Materials to be circulated with Council Agenda), subsection 11.2.1 is updated to include the following wording "The delegation request form will be included as part of the agenda package" as this is currently being practiced at the request of County Council.
- Section 11.2 (Delegations, Presentations and Materials to be circulated with Council Agenda), subsection 11.2.2 is changed to limit speaking to a period of not more than ten

minutes (from fifteen minutes) based on the results of a poll conducted of the Area Municipalities within the county – refer to Table 2 below.

- Section 11.2 (Delegations, Presentations and Materials to be circulated with Council Agenda), subsection 11.2.3 is changed to include the following wording: "Delegation requests will be granted only for those wishing to speak to subject matter directly aligned with Oxford County services and/or Strategic Goals".
- Section 14.16 is removed as it is contradictory to the Schedule B "Electronic Meeting Protocol".
- Schedule B "Electronic Meeting Protocol" is updated to include the following wording under conduct: "Staff and members of the public participating in a meeting electronically must use both video and audio when addressing Council".
