5.1.1 Application for Official Plan Amendment OP 22-20-1 – Telephone City Aggregates Inc. and 882527 Ontario Ltd.

The Chair asks Gord Hough, Director of Community Planning to present the Application. G. Hough, through use of a map indicates that the application proposes to include a site-specific development policy to permit a warehouse facility within the Agricultural Reserve on lands located on the north side of Oxford Road 29, immediately east of the Highway 401 interchange, and are municipally known as 806721 Oxford Road 29 and 806727 Oxford Road 29 in the Township of Blandford-Blenheim.

G. Hough indicates that Planning staff have considered the proposed warehouse facility in accordance with Provincial Policy Statement (PPS) policies for non-agricultural uses, adding that the subject lands do not comprise a specialty crop area as defined by the PPS and the Agricultural Impact Assessment submitted by MHBC Ltd. appears to confirm that the

proposed use complies with the Minimum Distance Separation requirements from nearby livestock/poultry operations. G. Hough further adds that the location of the use would appear to have merit in that the site is located on a County Road designed to facilitate truck traffic and is in close proximity to Highway 401.

G. Hough indicates that staff are of the opinion that the need for lands to accommodate the use at this location, particularly in the context of considering alternative locations, has not been adequately established in the context of the Township of Blandford-Blenheim or Oxford County, adding that there would appear to be a reasonable alternative for the establishment of this use in nearby Drumbo, which has approximately 21 ha (51.8 acres) of contiguous industrially designated lands. While the layout of the lands in Drumbo are of a somewhat irregular configuration compared to the subject lands, the Drumbo lands, which consist of two separately conveyable lots, could provide an option that would avoid prime agricultural areas. In closing, G. Hough indicates that staff are not recommending approval of the proposed Official Plan Amendment as it is not consistent with the relevant policies of the Provincial Policy Statement and does not support the strategic initiatives and objectives of the Official Plan regarding non-agricultural uses in agricultural areas.

The Chair opens the meeting to comments and questions from members of Council. G. Hough responds to comments and questions from Deputy Warden Acchione and Councillors Peterson and Petrie.

Dave Aston from MHBC Planning and Greg Sweetnam, the Agent for Telephone City Aggregates join the meeting in the Council Chamber and proceed through a presentation which was included on the agenda.

The Chair opens the meeting to comments and questions from members of Council. The presenters respond to comments and questions from Warden Ryan, Deputy Warden Acchione and Councillors Gilvesy, Mayberry, Palmer, Petrie and Wheaton.

Casandra Owen and Jason Degan, residents of Oxford Road 29, Drumbo join the meeting in the Council Chamber and express concern over agricultural lands being developed, asking that Council consider the neighboring homes and families who would be negatively impacted when considering this application.

The Chair opens the meeting to comments and questions from members of Council. There are none.

Dirk Boogerd, President of the Oxford County Federation of Agriculture joins the meeting in the Council Chamber, referring to written

correspondence which was included as an attachment to Council Report No. CP 2023-282 in opposition to the proposal.

Therefore be it resolved that staff be directed to return a report outlining possible policy solutions for Oxford's Official Plan and the Provincial Policy Statement that would allow future development and would direct such uses to unserviced land outside growth boundaries and along main transportation routes with the intent of better utilizing serviced land and transportation infrastructure.

Shawn Shapton, Executive Director

Re: Update on 24/7 Shelter Model

S. Shapton joins the meeting in the Council Chamber and introduces some members of his staff who were in the gallery, thanking them for the excellent services and care they provide to Operation Sharing's clientele during these unprecedented times. S. Shapton proceeds through a presentation which was included as part of the agenda, indicating that the main issues clients are facing are homelessness, mental health issues and addiction, asking that Council place humanity before dollars. Some of the priorities identified by S. Shapton include the need for a fair, long-term contract with funds allocated to create opportunities for individuals, a stand-alone facility offering a client-centered approach with wrap-around services and the need for detox and crisis beds in Oxford County as they are all currently allocated to Elgin County through Southwestern Public Health. In closing, S. Shapton indicates that the current system is not working and that the problems continue to grow. For this reason, if Council wants to see change, a different approach is required and reminds everyone that kindness matters.
