

COUNTY OF OXFORD

BY-LAW NO. 6807-2026

BEING a By-law to amend Schedules “C” and “D” of By-law 5725-2015, as amended, to provide for speed limits on County Roads.

WHEREAS, the Table to Section 11 and Section 52 (3) of the Municipal Act, 2001, S.O. 2001, Chapter 25, prescribes that specified highways are within the jurisdiction of the County of Oxford for all matters relating to those highways, including parking and traffic.

AND WHEREAS, the Highway Traffic Act, R.S.O. 1990, Chapter H.8 authorizes a municipality to prescribe speed limits for motor vehicles driven on any highway or portion of a highway under its jurisdiction.

AND WHEREAS, Council passed By-law 5725-2015 containing Schedules “A”, “B”, “C” and “D” on August 12, 2015.

AND WHEREAS, Council passed amending By-laws No. 5764-2015, No. 5786-2016, No. 5817-2016, No. 5848-2016, No. 5859-2016 and its amending By-law No. 5881-2016, No. 5889-2016, No. 5934-2017, No. 6019-2018, No. 6086-2019, No. 6132-2019, No. 6177-2019, No. 6247-2020, No. 6280-2020, No. 6301-2021, No. 6339-2021, No. 6361-2021, No. 6373-2021, No. 6446-2022, No. 6510-2023, No. 6529-2023, No. 6554-2023 and No. 6600-2023.

AND WHEREAS, Council has adopted Public Works Report PW 2026-03, on February 25, 2026;

NOW THEREFORE, the Council of the County of Oxford hereby enacts the following:

1. That Schedule “C” of By-law 5725-2015, is hereby amended by adding the following wording:

“County Road 2 – 350 metres West of the West limit of Gobles Road, Gobles to 30 metres East of the East limit of West 1/4 Townline Road, Gobles”.

“County Road 29 – 1200 metres East of the East limit of County Road 22, Windfall to 690 metres West of the West limit of Hubbard Road, Windfall”.

“County Road 59 – 650 metres North of the North limit of County Road 13, Holbrook to 230 metres East of the East limit of County Road 46, Holbrook”.

“County Road 59 – 600 metres South of the South limit of Quaker Street to 1000 metres North of the North limit of Quaker Street”.

2. That Schedule “C” of By-law 5725-2015, is hereby amended to remove the following wording:

“County Road 8 – 230 metres West of the West limit of County Road 3, Washington to 480 metres West of the West limit of County Road 3,

Washington”.

“County Road 8 – 350 metres East of the East limit of County Road 3,
Washington to 600 metres East of the East limit of County Road 3, Washington”.

3. That Schedule “D” of By-law 5725-2015, is hereby amended by adding the following wording:

“County Road 53 – County Road 2 to 350 metres East of the East limit of
Subway Line”.

“County Road 119 – 1000 metres West of the West limit of 25th Line, Dickson’s
Corners to 200 metres East of the East limit of 25th Line, Dickson’s Corners”.

4. That Schedules “A”, “B”, “C” and “D” to By-law 5725-2015 with amendments consolidated to date are attached hereto and form part of this By-law.

READ a first and second time this 11th day of March, 2026.

READ a third time and finally passed this 11th day of March, 2026.
