COUNTY OF OXFORD BY-LAW NO. 6339-2021

BEING a By-law to amend Schedules "A", "B" and "C" to By-law 5725-2015, as amended to provide for speed limits on County Roads.

WHEREAS, the Table to Section 11 and Section 52 (3) of the *Municipal Act, 2001, S.O. 2001, Chapter 25*, prescribes that specified highways are within the jurisdiction of the County of Oxford for all matters relating to those highways, including parking and traffic.

AND WHEREAS, the *Highway Traffic Act, R.S.O. 1990, Chapter H.8* authorizes a municipality to prescribe speed limits for motor vehicles driven on any highway or portion of a highway under its jurisdiction.

AND WHEREAS, Council passed By-law No. 5725-2015 containing Schedules "A", "B", "C" and "D" on August 12, 2015.

AND WHEREAS, Council passed amending By-laws No. 5764-2015, No. 5786-2016, No. 5817-2016, No. 5848-2016, No. 5859-2016 and its amending By-law No. 5881-2016, No. 5889-2016, No. 5934-2017, No. 6019-2018, No. 6086-2019, No. 6132-2019, No. 6177-2019, No. 6247-2020, No 6280-2020 and No. 6301-2021.

AND WHEREAS, Council has adopted Public Works Report No. PW 2021-10, on March 24, 2021.

NOW THEREFORE, the Council of the County of Oxford enacts as follows:

1. That Schedule "A" of By-law No. 5725-2015, as amended by by-law 6280-2020-, is hereby amended by adding the following wording:

"County Road 119 - 30 metres South of the South limit of County Road 16, Kintore to 225 metres South of the South limit of County Road 16, Kintore, for specific times, being from 8:15 a.m. to 9:15 a.m. and 3:00 p.m. to 4:00 p.m. Monday to Friday when school is in session".

2. That Schedule "B" of By-law No. 5725-2015, as amended by by-law 6301-2021, is hereby amended by removing the wording respecting the first reference to County Road 18, and replacing the wording to read:

"220 metres West of the West limit of Spring Street, Norwich to 370 metres East of the East limit of Phebe Street, Norwich".

- That Schedule "B" of By-law No. 5725-2015, as amended by by-law 6301-2021, is hereby further amended by removing the wording respecting the first reference to County Road 19, and replacing the wording to read:
 "25 metres West of the West limit of James Street, Otterville to 160 metres East of the East limit of York Street, Otterville".
- 4. That Schedule "B" of By-law No. 5725-2015, as amended by by-law 6301-2021, is hereby further amended by removing the wording respecting the first reference to County Road 59, and replacing the wording to read:

"50 metres South of Robson Street, Norwich to 310 metres North of the North limit of North Street, Norwich".

- That Schedule "C" of By-law No. 5725-2015, as amended by by-law 6247-2020, is hereby amended by removing the wording respecting the first reference to County Road 17 and replacing the wording to read:
 "670 metres West of the West limit of County Road 30 East Zorra-Tavistock to 1,300 metres East of the East limit of 13th Line, East Zorra-Tavistock".
- 6. That Schedule "C" of By-law No. 5725-2015, as amended by by-law 6247-2020, is hereby further amended by removing the wording respecting the second reference to County Road 17.
- That Schedule "C" of By-law No. 5725-2015, as amended by by-law 6247-2020, is hereby further amended by removing the wording respecting the first and second references to County Road 18.
- 8. That Schedule "C" of By-law No. 5725-2015, as amended by by-law 6247-2020, is hereby further amended by removing the wording respecting the seventh reference to County Road 59.
- 9. That Schedules "A", "B", "C" and "D" to By-law No. 5725-2015 with amendments consolidated to date are attached hereto and form part of this By-law.
