COUNTY OF OXFORD

BY-LAW NO. 6361-2021

BEING a By-law to amend Schedules "B", "C" and "D" to By-law 5725-2015, as amended to provide for speed limits on County Roads.

WHEREAS, the Table to Section 11 and Section 52 (3) of the *Municipal Act*, 2001, S.O. 2001, Chapter 25, prescribes that specified highways are within the jurisdiction of the County of Oxford for all matters relating to those highways, including parking and traffic.

AND WHEREAS, the *Highway Traffic Act, R.S.O. 1990, Chapter H.8* authorizes a municipality to prescribe speed limits for motor vehicles driven on any highway or portion of a highway under its jurisdiction.

AND WHEREAS, Council passed By-law No. 5725-2015 containing Schedules "A", "B", "C" and "D" on August 12, 2015.

AND WHEREAS, Council passed amending By-laws No. 5764-2015, No. 5786-2016, No. 5817-2016, No. 5848-2016, No. 5859-2016 and its amending By-law No. 5881-2016, No. 5889-2016, No. 5934-2017, No. 6019-2018, No. 6086-2019, No. 6132-2019, No. 6177-2019, No. 6247-2020, No. 6280-2020. No. 6301-2021 and No. 6339-2021.

AND WHEREAS, Council has adopted Public Works Report No. PW 2021-26, on July 14, 2021.

NOW THEREFORE, the Council of the County of Oxford enacts as follows:

- 1. That Schedule "B" of By-law No. 5725-2015, as amended by by-law 6339-2021, is hereby further amended by removing the wording respecting the second reference to County Road 20.
- 2. That Schedule "B" of By-law No. 5725-2015, as amended by by-law 6339-2021, is hereby further amended by removing the wording respecting the first reference to County Road 119.
- 3. That Schedule "B" of By-law No. 5725-2015, as amended by by-law 6339-2021, is hereby further amended by removing the wording respecting the second reference to County Road 119, and replacing the wording to read:
 - "640 metres North of the North limit of County Road 2 Thamesford to the North limit of County Road 2, Thamesford".
- 4. That Schedule "C" of By-law No. 5725-2015, as amended by by-law 6339-2021, is hereby amended by removing the wording respecting the first reference to County Road 20 and replacing the wording to read:
 - "890 metres West of the West limit of Dereham Line, Delmer to 430 metres East of the East limit of Dereham Line, Delmer".
- 5. That Schedule "C" of By-law No. 5725-2015, as amended by by-law 6339-2020, is hereby further amended by adding a second reference to County Road 20 with the wording to read:
 - "North Limit of Brownsville Road East of Dereham Line, Delmer to the South limit of Brownsville Road West of Dereham Line"
- 6. That Schedule "C" of By-law No. 5725-2015, as amended by by-law 6339-2021, is hereby further amended by removing the wording respecting the reference to County Road 24.
- 7. That Schedule "C" of By-law No. 5725-2015, as amended by by-law 6339-2021, is hereby further amended by adding a second reference to County Road 28 with the wording to read:
 - "235 metres East of the East limit of County Road 119, Uniondale to the east limit of County Road 119, Uniondale"
- 8. That Schedule "C" of By-law No. 5725-2015, as amended by by-law 6339-2021, is hereby further amended by removing the wording respecting the first and second reference to County Road 59.
- 9. That Schedule "C" of By-law No. 5725-2015, as amended by by-law 6339-2021, is hereby further amended by removing the wording respecting the fourth reference to County Road 119 and replacing the wording to read:

- "400 metres North of the North limit of County Road 28, Uniondale to 150 metres South of the south limit of County Road 28, Uniondale".
- 10. That Schedule "C" of By-law No. 5725-2015, as amended by by-law 6339-2021, is hereby further amended by removing the wording respecting the fifth reference to County Road 119 and replacing the wording to read:
 - "150 metres South of the South limit of Bates Lane, Thamesford to 640 metres North of the North limit of County Road 2, Thamesford".
- 11. That Schedule "C" of By-law No. 5725-2015, as amended by by-law 6339-2021, is hereby further amended by removing the wording respecting the sixth reference to County Road 119.
- 12. That Schedule "D" of By-law No. 5725-2015, is hereby further amended by adding a first reference to County Road 119 with the wording to read:
 - "150 metres South of South limit of Bates Lane, Thamesford to 560 metres North of the North limit of Bates Lane, Thamesford".
- 13. That Schedules "A", "B", "C" and "D" to By-law No. 5725-2015 with amendments consolidated to date are attached hereto and form part of this By-law.
