


2022 Budget Survey Responses

Quick facts

• Transportation Services is responsible for transportation planning, traffic calming and maintaining roads and bridges on Oxford's major roads and highways.


• The County maintains 1,228 lane kilometers roads and 161 bridges structures/culverts 39 intersections, 1,000 regulatory signs and 7 controlled pedestrian crossings. In 2020, 32 km roads were repayed and responded to 61 winter events that either met or exceed municipal service level standard.

• According to the current Asset Management Plan, the condition of the roads are rates as excellent and bridges are rated as good.

• Annually, the capital budget is increased by \$500,000 in order to sustainably maintain infrastructure systems in good condition.

County Question 1: Transportation Services – County Roads and Bridges

Enhanced

Add photo radar to roads, especially those where community planning was not well done (e.g. County Road 17) Add roundabouts rather than stop signs/lights.

In SW Oxford, pave East Hill Line in Beachville to Karn Road so Beachville residents can get to work and shopping in Woodstock easier.

Inter community transit would benefit rural areas and take pressure of urban areas and provide more business opportunities for both. economic growth etc.

Maintained or enhanced, preferably enhanced. There is so much speeding in this city it's not funny. We also have an unusually large number of people who shouldn't be driving at all. People who purposely blow through stop signs every single time they approach. I don't know if this is some kind of new "Tide Pod Challenge" or what the deal is but it's frightening. They increase their speed approaching the stop sign and just blow right through. Someone is going to be killed and this is happening at several stop signs through out the city. Traffic calming and increased fines by police would be a good start. Also move around the digital speeding signs that radar the speed, show the speed and tell people to slow down. People stop seeing them when they've sat in one place too long. WPD just needs to do unannounced blitzes throughout the year on each kind of traffic violation...a continuous cycle of blitzes. I feel one of the biggest reasons people do it is b/c they receive no consequences. If they were being stopped and ticketed, their insurance companies would make sure they straighten up and fly right, in a big hurry.

Overall condition of roads and bridges appears to be good. Gravel roads could be graded a little more often

Oxford county should be helping the townships pave all the roads in the county since they are used by members of the county. Unpaved roads cause major pressure on paved roads. It should be important to the county to pave all the roads within it instead of just saying it's the townships job.

Roads like Huron Street, Main Street, sections of Nellis street are HORRIBLE, and have not been repaired in years!!! Yet other roads have had several resurfaces done every 2-3 years. By all appearances, you fix the roads more used by visitors to the city to maintain a good image, but ignore the downtown (yet again!) where a main thoroughfare such as Huron Street is CONSTANTLY used by thousands of cars per day and hasn't been repaired in decades!!!!!

The roads are NOT good. In some places the are terrible. Car rattling bad. Bridges across the Thames need to be 4 laned. Vansit bridge reconstructed. Vansit/Dundas light. Impossible to make a L hand turn o to Dundas.

The roads in my community are not excellent so need a plan to fix this

Way too much traffic on our small roads now.

Wherever doable and especially in planned high traffic in newer development areas, roundabouts should be considered. The benefits are so much better when planned in advance for long term growth. This can even be included in industrial developments too. There are places where factories are actually built in the center of gigantic roundabouts. We also have to welcome the High Speed Train from London to Toronto.

Wider paved shoulders or dedicated trails for cyclists.

Our road is very poor at times.

I was in Paris recently and was happy to see "speed bumps" along the pedestrian walks. Norwich could use pedestrian walk ways in several places. This would make traffic slow down as too many vehicles actually race right through downtown. People are walking here! Tractors and pulling wagons and other gear should not be immune to 50Kkm or less. Like much of Canada, it takes WAY too long for roads to be repaired. Yes the roads are good etc., but the young and old should not have to walk on the roads to get their mail or go to school. What percentage of the budget is set aside for sidewalks? It should be enhanced.

More traffic calming actions would be nice to see in town. Especially in community safety zones and residential areas.

I feel the county is growing in a big way, and properly planning long term goals, traffic, flow etc is a big priority.

But if for a year all is good reallocate temporarily. We all know when there are too many funds allocated they are spent because the department would fear not getting in the next year. This thinking has to change and that starts at the top by allowing budgets to be reduced when not needed in a given year but reinstating the following year.

Focus on improving transit by syncing up lights in the city of Woodstock. Our town gets halted at rush hour by folks stopping at every red light on their commute.

I would like to see more roundabouts used within the community. I know the investment costs between roundabout vs. a 4-way stop or a traffic light are quite wide but the traffic flow is just so much nicer and easier to use. I would also like to see some wider paved shoulders that would allow safer biking/walking

Less sand on the roads, its unreal how much sand is put down in some areas.

Less urban sprawl to reduce pressure on our existing infrastructure. Increased housing density in downtown areas.

Managed this better. Reduce costs.

Need to improve all road crossings at watercourses to be clear span to allow for flooding and wildlife corridors

Please have someone come to the town of Bright- nobody seems to ever come and notice that our roads and sidewalks need maintenance.

I think that we have quality roads and bridges in Oxford, our infrastructure is in good shape. It is most noticeable when you travel slightly out of County to any of the neighbouring Countys. It seems like Oxford has more up to date infrastructure and roads.

I sincerely wish something could be done about the uneven sidewalks. I use a mobility scooter to get around and some of the bumps and cracks are awful, even on the paved sections of the walking trail. Terrible trip hazards as well. That is if you don't get killed crossing Canterbury St. between Memorial Park and Smith's Pond...some people turn the corner on two wheels and are under the misconception that the vehicles have the right of way. Very dangerous crossing. Paving the old horse track all the way around would be awesome!

Add passing lanes and turning lanes to Hwy 19 north.

Our city is growing because of Toyota. Encourage some growth. Our roads have to be maintained to have this happen.

I travel to Middlesex & Waterloo frequently. I'm impressed with the quality of road maintenance in Oxford overall but in particular during the winter months.

In the event of any new bridge construction or bridge replacement in Oxford County, I would like to see more attention paid to design aesthetics. Obviously, functionality and safety (and cost) are the most important considerations, but bridges of the past had architectural value as well. This doesn't seem to be the case anymore. Modern bridges all seem to be identical and uninspired in appearance. Maybe the County could have a design competition -- open to architectural students and vetted by qualified engineers -- when planning for a new or replacement bridge. This might not be practical for every new bridge, but could it not at least be considered on occasion? Also on the subject of transportation, to what extent has the County of Oxford looked into electrifying its fleet of vehicles? (Even a phased-in program would demonstrate impressive environmental leadership.)

Skipped Question

The planned Capex projects will enhance services. Consider the installation of physical speed control measures and/or means of monitoring, between more heavily populated areas (Woodstock/Ingersoll) to protect the H&S of our pedestrians and to generate funds for future asset management initiatives.


Quick facts

• Waste management services include curbside collection for garbage and recycling, depots and special events, large article pick-up, and services at the Oxford County Waste Management Facility (OCWMF) in Salford.

In 2020, the OCWMF handled over 96,000 tonnes of waste. Approximately 37,000 tonnes of waste handled
was diverted from the landfill including over 20,000 tonnes of finished compost and over 8,000 tonnes of blue box
recyclable materials. The estimated remaining life of the landfill is approximately 30 to 35 years.

County Question 2: Waste Management

Comments

Enhanced

1. we need a green bin curbside pickup program. more waste needs to be diverted 2. people abuse the large article pick-up rules need to change. most residents own cars and if the item is small enough to put in a car they should drive it to the depot themselves. something would need to be offered for those who cannot deliver their item to the depot. 3. educate residents on what can actually go in the blue box.

A green bin program should be started for all communities. The county is against the proposed new landfill but is not doing all we can to eliminate the garbage that we produce. This would increase what we divert from landfill.

Add a compost collection !

As a newer resident to the county, the recycling program is extremely lacking. We come from Guelph where the garbage was in reusable bins, not plastic bags, and recycling was collected more than garbage because everything was recyclable and garbage was discouraged. These programs obviously cost money to initiate and get geared up so this budget needs to be enhanced.

as long as does not put up taxes, find other ways to save within

Bag tag costs drive residents to dump garbage illegally, especially when they come from cities where the first 1-2 bags of garbage were free. This behaviour, combined with new construction at the city's periphery, will worsen rodent problems.

Bag tags are ridiculous for what we pay in taxes and no compost pickup. Not to mention the guys picking up the garbage picking through etc.

Better system for recycling would be good Lose the bag tag fee

Collect recycling weekly Collect compost in green bins to divert further garbage from landfills

Curbside green bin for organics pickup would reduce waste significantly.

Community Centre, and while the recycling bins are there--EVERYTHING goes in the landfill. This is the same for ALL large public areas. Educate the public, make it easy and accessible to recycle, but actually do it!

Enhance to include a green bin organic pickup program as well as weekly recycling pickup and more frequent large item pickup.

Enhanced to include Kitchen waste pickup as well as but not for me personally, weekly recycling as I'm always hearing families say they have too much recycling piling up. Waste management issues are not high on my priority list for this survey though. It wouldn't even be in my top five. Again, Addiction related Crime, Addiction itself, Mental illness and Homelessness would be my top priorities in this city.

Enhanced to include organic program ASAP.

Green bin and yard waste pick up would be nice and would reduce these items going to the landfill I am not a tan of bag tags for garbage. I feel its a double edged sword. Meaning, as I reduce my garbage I buy fewer tags. If everyone in town bought fewer tags then we have less revenue from the tags to pay for the garbage collection. However, does the cost of garbage collection go down when there are fewer bags collected? Does the driver of the garbage truck accept a lower wage when there are fewer bags to collect? If not, then we are forced to pay more per tag to make up for buying fewer tags. If we had a green bin program to collect most food waste we could get away with 1 bag of garbage every 2-3 weeks. I really am in support of a green bin, but fear that it will make our garbage bag tags increase in price since there will be fewer tags purchased.

I feel waste management and recycling efforts should be increased everywhere.

I personally am not happy with out latest contract for garbage and recycling removal. The list of things we can no longer recycle (which IMO should be recycled the most!) was eliminated. We need a contract that encourages recycling to it's fullest, keeping much needed plastics out of our landfills.

I think our taxes are high enough as it is considering we pay for garbage tags

I'd like to see a food waste pick up program with user fees. ie. Green bins Back yard food compost encourages pests. Food waste in garbage encourages wildlife to tear it apart. Food waste compost in county facilities can yield rich, garden compost for everyone.

Increase recycling to every week, better advertise options for green waste/composting (food, grass, leaves)

it's time for curbside compost.

Large item pick up should be increased to twice per year and include hazardous waste such as paint cans, used motor oil etc. Cameras should be installed at the Drumbo leaf/brush dump to catch and prosecute those who continue to abuse the facility by dumping garbage items there.

Like to see items collected for recycle enhanced

More diversion.

More items allowed in recycling

More recycling of more materials. Stop requiring garbage bags in garbage pails! That is stupid and contradicts the purpose of using pails to reduce the use of plastic going into the dump.

Not everyone has the ability to take large articles to the landfill and it would be great if there was a large article pickup twice a year, with expanded variety of items.

Offer kitchen green bin compost service to all residents.

Our recycling and compost options in Ontario are lacking. Need to increase the diversion options to keep our landfills free of items we can use alternatively.

Our Recycling program is among worse I've seen and I am familiar with others, including in Europe. The amount of items not accepted in recycle is outrageous. putting those items into garbage and sending it to landfills is very irresponsible and shameful, it's 2021 and we still don't have effective recycling program. Shame on OXFORD county.

Please enhance to weekly recycling pickup.

Please increase recycling pickup to every week.

Please reconsider contracting waste collection to private companies and make these jobs and services county efforts. Enhance composting and recycling, continue waste reduction, fund environmentally beneficial residential building/renovations.

Put limits on the number of garbage bags set out on the curb and removed the cost of bag tags.

Quit accepting lowest bid for contractor

Right now our waste management strategy does not align with our green agenda. We should be immediately implementing a green bin program with weekly collection. We should be collection recycling weekly and garbage bi weekly.

Should have a second large article pick-up.

Since the change from Emterra to the new contracted company has been a disgrace. The new company does not accept the range of materials that Emterra did and therefore leads to WAY too much now having to go to the landfill. This is NOT the direction that Oxford County claims to want to go, so why this new company was chosen makes zero sense. The return to Emterra is essential to constituents and council alike in my opinion.

Start recycling many more things or incinerating it like (Peel Region) and stop complaining about a dump Tillsonburg and all municipalities in Oxford County should get a bulk pick up at least once a year or even two would be better. It could be based on a calling a number and the bulk pickup could be arranged.

We already pay a lot for waste management, the bag tags seem a bit like gouging. Also, we used to have a much better recycling programme in Ingersoll than we currently have. For example we used to be able to recycle styrofoam and plastic packaging. It was very disappointing to see this service decrease.

We need green bins.

Weekly recycling

Weekly recycling pick up in the City of Woodstock.

Wheel bins would be an excellent addition.

would like to see compostables recycleing

We need big garbage options more than once a year!

We need a green bin program in this region

Improve the recycling. We should be able to recycle styrofoam, including trays, as well as all plastics.

I would like to see an electronic waste drop off and hazardous drop off somewhere in the vicinity of Drumbo. The last hazardous waste day was 3 or 4 years ago in Bright.

Salford is too far for all areas of the county. People just dump microwaves and tvs at the edge of ditches and fence corners. Large article pickup is too narrow in scope. Need once per year able to get rid of stuff curbside.

Would be nice to have 2 large item pickup dates per year.

Landfill is so far from us. We also should have the option of compost pickup in smaller neighborhoods. Compost waste in a small backyard is not appealing, smells, and attracts pests.

I would like to see the bigger wheeled/covered recycle bins come to Tavistock residents. Perth county uses these and I've heard positive feedback about it.

Compost services needed

We would like to be able to recycle our plastic bags again. It is very difficult and sickening to have to put them in the garbage after many years of being able to recycle them.

Increased options for recycling and diverting of waste. Encouraging individuals to divert personally with low cost, easy to use options. Monetary benefits for reducing waste.

I would be comfortable with higher taxes if the money were used to divert waste from landfills

Green recycling, please!

Current waste management is poorly handled and VERY unhappy with who the county had contacted out. Service is poor weekly, and recycling and trash collection is inconsistent with rules on tag.

It is important to improve efficiency and efficacy of recycling and waste management, and im willing to increase payments to allow for that.

I would like to see a waste management separate for all compost items.

Compost program

The County stopped to recycling of lose plastic such as shrink wrap, grocery bags. This makes up a good 5 to 10 percent of my household recycling and needs to be brought back. Green bins should be introduced for organic waste including food scraps.

I would like to see a better recycling program

Get a recycling contract where they pick up plastic bags and styrofoam like they used to. These current people don't do this so what's happening with these items? Going to a landfill? If so, not acceptable!

Large article pickup option should be available to residents of Tillsonburg, for those that don't have access to a truck to take themselves to the transfer depot or Salford

There should be a compost collection which would reduce the amount of garbage to be collected.

A green garbage program (ie. diverting household vegetable and garden waste from the landfill) could be instituted. We are newly arrived from Barrie, ON and were surprised to see no green garbage disposal in place. As it stands now, all the easily biodegradable garbage is lumped in with plastics and other waste that takes much longer to break down. Alternatively, an enhanced composter program should be started up; make it easier to get the composters. Education is the key to the success of either program.

we need to recycle much more.

We need green bin option and better recycling options - too much that cannot go into blue bins.

Tillsonburg should have large article pick-up since we have a large senior population with no way to get large items to depots

here in town is a joke with terrible hours for anything other than yard waste. In a town that thrives on attracting urban dwellers and seniors, you would think there would be large item pick up twice a year at the curb.....like most areas in the county. The people you are trying to attract don't have trucks and trailers after all.

Would love to see a green box program from September to May. I say not for June through August because the maggot situation is disgusting when you put your stuff in a green box during that time

Curbside compost diverted to a biodigester for an energy source would be fantastic for Oxford!

Invest in incineration

Our recycling program should be weekly not biweekly. I also think we should have an organics program

Weekly garbage and recycling pick up is needed. And get rid of garbage tags. It should be free at least 1 or 2 bags.

Keep these places operating.

Divert foodstuffs away from landfills.

I love the recycling & large item depot. I wish the old recycling depot was still available, especially if weekly recycling program can not be established. Sometimes the depot's hours are not practical & I need to empty my recycling bins more than every two weeks.

After living in Brampton for 3 years while attending college I find the waste management in Woodstock incredibly frustrating. Buying bag tags is a hassle and throwing away food waste saddens me, and makes the garbage smell. I rent so I can not use a backyard composter. We need better systems in place.

Green bin pickup?

Why are we still paying for garbage on top of our taxes? There could be a large improvement in recycling services including green garbage.

We pay\$ 2.50 per bag tag . Plus taxes for ware collection. Other towns and counties have more current updated service , don't have to go buy tags

Shouldn't have to pay for bag tags if we're paying all this tax money for waste collection. One or the other please.

A green bin program should be explored.

There is currently a number of plastic and styrofoam products that are not accepted in the blue bin and thus placed in black garbage bags destined for the landfill. These products were all accepted at the landfills in my previous jurisdiction of Niagara region. Our landfill needs to be updated to receive these extra products which are recyclable as indicated by the recycling logos on the products. Furthermore it is entirely unacceptable that the landfill was closed to the public for such a long duration of time during the covid shutdown. This only led to people littering their garbage on back roads and side roads.

I would be interested to see an enhanced recycling/composting program.

These garbage tags are a huge waste of stickers!! You need something better in place we need to have collecting every week and would be better if it wasn't a different day each week!

Just get rid of those bag tags, they are just a royal pain to have to deal with. The cost of picking up our garbage should be included in our property taxes. Also it would be nice if there were two large pickups each year; the second being in the fall.

I wanted to make several points about the County's Waste Management program, but unfortunately I have run out of time, and I believe it's better to submit what I have completed elsewhere in this survey before the deadline.

Large article has been reduced so drastically it needs to go back to where all non hazardous items were taken. Most residents don't have a means to go to the dump. A recycle depot is required so that residents don't have to wait inline at dump to drop of recyclables etc that is free. Bag tag is good. We are happy with collection. Not happy with the plastic situation (no longer to be put in recycle) When calling the Township Dept. because of missed pickups, I only expect a reasonable answer to why, we don't need to be accused of not getting our refuse out before 7am especially when an entire street is missed. This has happened several times. Don't appreciate that. We pay our taxes. We are not children.

I am concerned about the lifespan of the landfill. What is being done to address the need for a new landfill in the future?

Oxford County needs to find a source for better recycling of more types of plastic.

Awesome job...except for the plastic recycling.

I think that Oxford County has the best waste program in Ontario. Having to pay for garbage tags cuts down on how much people recycle because we know that every bag we put out costs \$2. The only thing that could be added is some kind of pickup for 'wet' waste like vegetable peels etc. We compost them, but people living in apartments are unable to do that.

I don't mind the cost of the garbage tags. this is better than raising taxes.

Allow more items to be dropped off at the Tillsonburg landfill instead of us having to drive to Salford. Seems a bit unfair that everyone outside of Tillsonburg can leave all their big items for pick up once or twice a year yet we can't.

I would love to see a large item curbside pick up (even 1x every 5 years). This might reduce dumping. Oxford County should return the hazard waste collection day so more waste goes where it should. Bag tags should only be required after the first free bag.



There is never enough high quality child care/child welfare services. Perhaps if we invested more in these areas for children, we would have to invest in fewer other services (eg. police, health, etc.)

Child care in Tillsonburg is less than perfect. For the amount of young families that live her, there are three to choose from. If you live here and have a job, a six month waiting list at these facilities is entirely unacceptable.

We need more facilities. The wait lists are insanely long and it's near impossible to get registered child care

There is a severe lack of quality child care availability, as well as no assistance/astronomical care prices for middle class families.


• In 2020, 125 rent supplements were provided. This program is to bridge the gap between the actual rent and rent affordable by the family/individual.

 Community Homelessness Prevention Initiative (CHPI) is a 100 per cent provincially funded outcomes-based program that aims to prevent and end homelessness by improving access to adequate, suitable, and affordable housing and homelessness services for people experiencing homelessness and for people at-risk of homelessness.

• This program has assisted between 800 to 1000 people per year and has assisted with last month's rent, prevention of evictions, prevention of utility disconnections, funding to the emergency housing at The Inn, Salvation Army Emergency House as well as many motels and hotel stays as necessary. It also supports the Housing with Related Supports program and other agencies involved with housing throughout Oxford County.



• Woodingford Lodge is a municipally funded LTC home receiving 37% of its funding from Oxford County property taxes, 43% from the Province and 20% from LTC residents.

residents in Ingersoll and 34 residents in Tillsonburg. There are approximately 600 people on the waiting list for
one of the three Woodingford Lodge homes.

COVID-19 has brought to light the failures of these LTC homes

Given the past 18 months, it has been very clear that only municipally funded LTC homes provided adequate supports and services to keep residents safe and well provided for. There is a crisis with limited quality beds available in modern facilities that meet current standards. Our community requires more investments in this area.

If COVID showed us anything it's that LTC homes need additional funding for staffing, PPE when needed, climate control (air conditioning) etc.

If there is a 600 person long wait list for 228 spots this seems like an issue. Maybe we need to increase funding to create more beds. Build another home in Tavistock. We lost Bonnie Brea. Buy out the private ones and get rid of for profit corporations. They are low level and don't compare to Woodingford. The pandemic proved that!

We would like to see some appropriate seniors housing options for our aging parents, something that starts out as an apartment and can transition into assisted living and eventually nursing care at an affordable cost. This is precisely what my parents are looking for and the options for them are very slim to non-existent in this area. 10-year waiting lists are unacceptable.

Recently having a family member in Woodingford Lodge, I am grateful for the care but have witnessed that education and staffing needs to be enhanced and improved.

600 people on the waiting list seems like a lot, so something needs to be done differently here. Do the LTC residents pay based on ability or is it a flat rate of 20%? My thought is the payment should be geared to ability to pay based on assets and income of the resident. Is there a plan to expand and add more beds?

Looking back at the Woodstock location, there were some terrible decisions made during its construction which resulted in major cost overruns. Let's be sure to not let anything like this happen again in order that the money may go to where it will do the most good.

600 people are waiting to get into one of the Woodingford Lodge facilities? 600? Are you kidding me? Where are all of these people -- most of whom I presume are elderly -- living in the meantime? Who is caring for them? The system seems to be seriously lacking if that many folks are relegated to a waiting list. To the extent that it can, the County needs to pressure or lobby the Province of Ontario to provide funding for more beds.



Build another base within 10km of Tavistock. It is shameful that Stratford Medics (Perth County) responds here as much or more than our County Service does. Fix it!

As Tavistock is growing, it would be nice to see a station moved closer to the largest population north of Woodstock. Why is there a station near no one (between Hickson & Embro)?? Shouldn't this be located between Hickson & Tavistock??

Need to ensure we are planning for future needs - in advance of needing them.

These guys earn their money and I want them to know that their community values them.

Oxford county needs more advanced care paramedics.

Landsdowne facility improved.

We need them has much as the Fire Department and Services. Lets keep them safe and their mental health in check.

The need for emergency medical care never goes away and as the community ages, it becomes more and more necessary. I believe Paramedic services need to expand as far as emergency 911 services but a Community Paramedic program involving multiple agencies (Oxford PCOT, Home and Family Wellness, High Intensity Support in Home, Addiction Support Services Etc.) is very much needed as well. It should be at the level of the Long Term Care budget as least.

Need more trucks/ stations/ rotations, funding! This is a quick growing community!!!

Increase EMS presence in Zorra Township

As seniors age, they need more medical care. There is only one place in Ingersoll where we can go for blood work etc. We should have at least 2 of them.

Someone living within eyesight of the ambulance depot shouldn't have to wait for the ambulance to come to town from Mt. Elgin while they are having a heart attack!

An absolutely critical service - need to also improve the situation in emergency rooms and the turnover of patients that are brought in by ambulance so that paramedics can leave the patient and take care of other calls, rather than just waiting in the emergency room with the patient they brought in.

Definitely due to increasing population whether they live here but commute to their jobs, housing here was more affordable if they sold a home in Toronto Hamilton or . and saw a opportunity for a good financial investment The closeness to highways and miles of rural roads make emergency services more in need and the quicker the response the better to stabilize any condition



Below I have added an excerpt from some comments I made in the Town of Ingersoll section of this survey. I think the words bear repeating here because the issue they relate to is so important and is one on which the Community Planning Department, in its role of overseeing land use in Oxford County, has the potential to effect positive change: "I would like to see he highest priority placed on the protection of our remaining woodlands and wetlands in the immediate Ingersoll area and in the rest of the County. We have lost so much of our natural heritage in Oxford County, and, sadly, we continue to see woodlots and thickets and wetlands (not to mention farmland) fragmented or nickel-and-dimed out of existence due to relentless development. Just how many ugly, cookie-cutter subdivisions are enough? How many unattrac ive strip plazas and fast food joints are enough? When does it end? Does it ever end? And if it doesn't, what will our town and county look like in 50 or 100 years? Will there be any nature left here? If we rely on the vision of developers to guide or influence our municipal planning, here certainly may not be." And here are some additional thoughts of mine: - The County's Community Planning Department (or a newly-created and independent Ecological Services Department) should consider hiring a "Biodiversity Planner," whose job, in part, would be to assess any planning application -- especially any large land development proposal -- hrough an environmental lens, rather than an economic one. The purpose here would be to ensure that a proposed development does not in any way undermine or erode Oxford County's remaining natural heritage features. No development that risks doing so should be approved. A further responsibility of the Biodiversity Planner would be to help lead the County's efforts to EXPAND our natural heritage base. If Oxford County is to seriously do its part in combatting climate change and preserving/restoring biological diversity, then this expansion needs to happen NOW. - As an alternative to (but ideally in concert with) he creation of the position of Biodiversity Planner, a "Forest Protection Specialist" should be hired by the County. This person would be an advocate, a public educator, a program leader and, where necessary, a by-law enforcement official with regard to the publicly- and privately-held woodlands of Oxford County. The position would be different from a traditional forester in that woodlands and woodlots would not be primarily viewed as potentially harvestable resources, but rather as critical, living ecosystems that are necessary both for the preserva ion of our county's native plant and wildlife species and for the protection of our own human health (through the production of oxygen, the absorption of carbon, the protection of groundwater supplies, and the fostering of good mental and physical health through the experiencing of nature, etc.). The Forest Protection Specialist's mission would be to ensure that he county's remaining wooded areas are not diminished by residential and commercial development or by landowner misuse; to educate the public about the environmental value of woodlands (and trees in general); and to direct and assist in the implementation and promotion of a massive tree-planting campaign in collaboration with any local nonprofit groups that are already involved in reforestation projects in Oxford. - It is my understanding that Oxford County takes in approximately 500,000 acres. So why not set a tree-planting goal of at least 500,000 trees? Whatever the number, the ultimate goal should be to create a system of biodiverse forests in Oxford that are linked as much as possible by ecological corridors. This should be done using tree and shrub species that are native to Oxford County and that are suitable to a given plan ing site and to a given area of the county. (For instance, native upland tree species should not be planted in lowland areas and vice versa. Similarly, a tree species native to the sou hern part of the county might not be naturally found in the northern part of Oxford and therefore should not be planted there. Species and site selection should always be compatible and natural.) - Further to the idea of striving to create ecological corridors, how about County planning or environmental staff leading he implementation o what I will call a "Forests for Fencelines" campaign? Fencelines in an agricultural region like Oxford are widespread and are logical candidates for wildlife migration routes. These routes could be augmented/facilitated with he help of a project focussed on extensive native tree and shrub plantings alongside fencelines hroughout the county. Such a project would also help increase the overall natural vegetation cover in Oxford [and also prevent soil erosion]. (According to information I have read, the County's natural vegetation coverage, as of the year 2016, amounted to only about 17% of Oxford's total land area. By any objective ecological standard, especially in an era of indisputable climate change and species decline, this is simply not enough. Our county needs to do more to reverse the loss of natural habitat. There is no political or bureaucratic excuse not to.) - In order to protect existing woodlands and ensure hat they are not further fragmented, there should be no future building permitted whatsoever in the wooded areas of Oxford County. This prohibition would include houses and commercial buildings, including agricultural-related structures. The breaking up of intact woodlands into smaller pieces by even a single house or two makes hem more vulnerable to the encroachment of invasive plant and animal species, and it has also been proven to be highly detrimental to many forms of native wildlife, such as those birds that require undisturbed tracts of forests to be able to breed and raise their young successfully. - I have made some strong statements above. But they are valid. One might ask, though, if they contradict he comments I made in the section of this survey on Human Services and Housing. I don't think they do. I still believe that every person deserves a home, whether this be a house or an apartment or some other form of safe, affordable dwelling. However, we also have a moral obligation, and a practical one, to protect our larger home -- the earth -- and this protection begins at the local/regional level. To accomplish it, we need to find new and different ways to accommodate the housing needs of people, as well as the commercial needs of our communi ies, and not just continue to rely on the old-fashioned method -- the developer's preferred method -- of cutting down trees, bulldozing wetlands and paving over large tracts of farmland. It is the responsibility of our municipal planners and politicians to find hese new ways.

With the rapid growth of our communities, there needs to be real thought into long term planning. The developments in the north end of Woodstock reek to me (admittedly as an "outsider" of the industry), of little to no planning for the long term. Cookie cutter "copy, paste" houses thrown up as quickly as possible, with little to no services available on that side of the reservoir. Sure it will grow the population and tax base, but at what costs?

More natural environment needs to be maintained. Much of Tillsonburg's wildlife along the trails is being removed and housing put in its place!

I stated above, there should be more lenient towards allowing residential homes to become legal duplexes. Additionally there should be more consideration to developing commercial land for the purposes of shopping, restaurants and entertainment.



Use of electronic resources went up by 38% in 2020. People turned to the library for lifelong learning opportunities throughout the pandemic with 13,415 Universal Class online courses taken – almost 3,000 more courses than were taken in 2019.



While I understand it is well water and there is a limit to what can be done, I would love to see a system wide ro installed and then there would need to be some reminerslization added. I know this is a huge job and nowhere near as easy as it sounds, but the quality of what we receive out of our tap is disgusting for a country like Canada. I am embarrassed when I have visitors to tell them they can only drink out of the ro spigot.

Water is vital for life.

Without quality water, nothing else matters. We must kick the planned dump out of this area of ours. A disaster waiting to happen which will cause us to need to get water from Lake Huron at great expense for the survival of the entire area population

Work to soften the water so it doesn't destroy appliances

The waste water dump in Tavistock is noisy and smells. Not sustainable for a growing community and costing a lot money to upkeep with growing population

We only clicked enhanced because water should not be messed around with. We think we have good and ample water, thank goodness. Township does a good job of this. Don't want a Walkerton to happen.

Some communites still living with septic systems. Should be all sanitary sewer systems.

We desperately need wastewater services in Brownsville. Our water table is incredibly high and causes issues to the whole community. We need waste water services!!

Ingersoll water is so hard that people have to have a water softener! No one buys hot water tanks because they only last for a few years because of that. Also, why does our water stink so much from Friday-Sunday?

The water is disgusting and undrinkable. Showering smells like chlorine constantly and the high fluoride is a disturbing addition.

The cost of municipal water and waste water is to high and should be lowered.

Our current facility is old and outdated, with the city expanding, it will not keep up with the demand of waste water and clean water needed.

Our tap water doesn't taste good anymore. This encourages people to buy plastic water bottles or forces them to purchase their own water filters

Safe drinking water is critical

Water is precious. There needs to be enhanced education of best practices in preserving groundwater and to control erosion, e.g. rain barrels, permeable services, wetlands preservation, dispersed flow, etc.

With the rapid development in the northeast corner of Woodstock I feel the water quality has declined substantially. Often in the morning I experience a smell from my water until about noon or so. I am concerned about drinking water quality, smells from the water when I launder my clothes or bath. My neighbours have mentioned similar concerns. I have not received much cooperation with city staff when attempting to articulate my concerns.

Wastewater services for Blandford-Blenheim please

The water in Drumbo is actually scary. Constantly discoloured, but the county tells us it's supposedly safe. I'm not so sure. We have a water softener AND a filtration system, and our appliances are still consistently caked in deposits. That can't be healthy for us. We're also paying significantly more than we've ever paid for water in multiple regions.

Despite the water quality in the Mount Elgin area passing provincial safety standards, the quality, taste and mineral content of the water is disappointing to say the least. It creates an undesired flavour and heavy deposit buildup in plumbing, appliances and showers. My water currently measures 355 ppm of total dissolved solids - this is twice the amount measured in the tap water of my previous residential area of Niagara Region. I am lucky to get 2 or 3 weeks out of my water filter before it needs to be replaced. The unfiltered water is undrinkable to my family.

If the annual cost of my water and wastewater services were to be teased out of my ERTH Power utility bills and applied to my property taxes instead, it would be the largest contributor to my tax bill of all the various County-provided services. The high cost of electricity in Ontario seems to get most of the public's attention, while the cost of water and wastewater services almost flies under the radar. For me personally, water and wastewater charges are regularly double that of the electricity portion of my utility bill. And these charges seem to increase every year. I don't like this as a taxpayer, but at the same time I also understand the huge importance of these services. After all: no water, no life. I also recognize that water-related infrastructure doesn't last forever. Eventually, it must be upgraded or replaced. On the wastewater side of things, I have some questions: - What is the level of sewage treatment at the various treatment plants in Oxford? Is it secondary or tertiary? (Ideally, it should be the latter.) - Where does the sewage sludge that is produced at these plants eventually go? - What is being done -- is there anything that can be done? -- to filter out the microplastics that are no doubt in the wastewater that arrives at Oxford's treatment facilities? Microplastics have become a real environmental problem, and I shudder to think about the sheer quantity of them that is being discharged into our county's watercourses. - I assume that the final stage of wastewater disposal is the release of the treated liquid into the Thames River or other county watercourses. What kind of waterquality monitoring is done downstream of these discharges and who (what agency) does this monitoring? What are the cumulative impacts of these discharges on fish and other wildlife, and on the general health of the Thames River? - Finally, might it be worthwhile for County staff to produce a pamphlet or a factsheet that describes in an easily understandable way how our wastewater is treated and where it ultimately goes? Let's face it: Most of us don't think about wastewater once it's flushed down the toilet. A factsheet outlining how it's dealt with might be very educational for people. It might even help to change some bad habits.



Comments

Addressing the homeless issue especially in the downtown core. Downtown revitalization is impossible without first addressing this issue. The downtown core is not a location suitable for meth clinics and homeless shelters. I have noticed recently that some homeless people have been sleeping in Victoria Park so they are spreading out. Create a charming and welcoming downtown for all by implementing a sustainable and permanent tree planting with flowers and shrubs in the centre of Broadway and allocate parking parallel to the curb allowing cars to drive away safely. Re-route transport truck away from the downtown Also build to own a proper city hall to be proud of and bring under one roof all the services that the town of Tillsonburg provides. Provide horse stalls around town, comfortable and pleasant for the horses. Why so many cannabis stores in a small town?

My families 3 top priorities are: 1. Adding green compost bins to weekly curbside garbage pickup. Charging more for garbage bags to promote more recycling/compost use. 2. I can appreciate some staff were needed, but seriously, "planning programs" for 18 months to not open the community centre/customer service centre is uncalled for. The staff from the town are for the most part unapproachable, rude and not held accountable. It feels there is a great lack of communication between the town and the community. Again, simply my opinion.

We need more infant daycare options, the wait list to get into a certified daycare that is not in a private home is too long. We need more midwives in town. There is only one in town that will take on patients and due to our distance to all other hospitals we have no other option, midwives from other cities will not take patients from Woodstock due to the distance from that city's hospital. Not everyone wants an OB or aligns with their care. And it is extremely challenging for us to get into the care of a midwife.

Many of the issues I've already outlined. If we deal with the 'affordable housing' issue, we would put a large dent in the other issues socially. Oxford county, especially Woodstock does not have a rent cap. We are now paying over \$2,200/month for a 3 bedroom where 2 years ago it was only \$1500. When families have to work 3 jobs to put food on the table (which is also increasing in price), it makes the idea of homelessness that much more real for everyone. Individuals in a geared to income housing situation are forced to remain there due to unaffordable housing options elsewhere. By doing so, it increases the wait lists and potential homes for those in need, thus increasing homelessness, addictions, and mental health issues.

I'm proud to live in Woodstock. It's clean & beautiful (flower beds especially)
