6.1 12th Annual Oxford Stewardship Award Presentation

Warden Martin presents the 2020/2021 Oxford Stewardship Award to Teresa Piraino, Blandford-Blenheim Township, in recognition of her and her family's efforts toward land improvement and sustainability. The winner of the Oxford Stewardship Award is chosen by representatives of local stewardship organizations, with Wes Hart, Soil & Crop Improvement Association, and Cher Sprague, Stewardship Oxford, leading the judging process. This year's other short-listed candidates included: John McRoberts, East Zorra-Tavistock Township and Chris Lee and family, Norwich Township.

Teresa was chosen by the award selection committee for her passion and commitment to preserving the natural beauty of their 55-acre property in Blandford-Blenheim Township. Teresa, a wildlife biologist, demonstrates how mixing work with pleasure is growing stewardship.

Teresa and her family have developed a one-acre wetland as well as different microhabitats and microclimates to attract and retain more than 1,000 different species of plants and animals they have recorded on their property. They have also created a pollinator field and have built large underground habitats to protect the snake population.

Teresa was among three short-listed candidates chosen from a pool of projects supported by the Clean Water Program. The program is funded by Oxford County and administered by the Upper Thames River Conservation Authority, and promotes water quality improvement, as well as woodland and wetland conservation and enhancement. All of this year's finalists undertook various land improvements to protect the local environment.

As the 2020/2021 winner, Teresa will receive a \$500 gift certificate towards the purchase of original artwork by Wendy Gielis and a gift basket of local products from Your Farm Market.

In addition to this prize, she will also be added to the recognition wall at the Oxford County Administration Building, designed to honour all past, and future, recipients of the Oxford Stewardship Award.

Teresa and Scott Piraino join the meeting via WebEx, and express gratitude for being recognized for their efforts and congratulate all of the nominees. S. Piraino thanks the many volunteers, local farmers, friends, family and organizations who have contributed to their efforts in the protection of local wildlife and in making the Snake Woods Nature Preserve possible.
